INSTRUCTIONS FOR ATTENDING THE NRA BASIC PISTOL CLASS

1. We must receive your **NON REFUNDABLE DEPOSIT** in the amount of \$40.00 per person prior to your class date or your seat will not be held. The total fee for this class is \$100.00. The balance of \$60.00 will be collected when you arrive for class.
2. Deposit may be in the form of a personal check, bank cashiers check, or money order. Make your check or money order payable to: **CSMMA**.
3. MAIL your deposit and this registration form to: **CSMMA, 9318 Marshall Road, Cranberry Twp, Pa 16066**
4. Deposits are **NON REFUNDABLE**. Some rare exceptions can be made for legitimate emergencies such as a death in the family. If you do not call, and you do not show up, your deposit is automatically forfeited.
5. **You must bring your own Eye and Hearing Protection for the range class (a peaked ball cap is recommended)**. The specifics will be discussed in the classroom session.
6. If you are bringing a gun with you, it must be unloaded and in a container that fully encases the firearm. We provide guns for use in this class.
7. Do NOT bring any ammunition with you into the classroom. It is not allowed in the classroom. We provide the ammunition for this class.
8. We provide the targets.
9. We provide all books and materials required for the class, & Firearms safety certification (NRA), provided you take and pass a written test.
10. Underage students (ages 10 to 18) may take this class. Underage students must have a parent/guardian present at all times.
11. Each person will be required to sign a liability waiver.
